When Are We Forced to Keep Bidding? When Can the Auction End?

One of the most important aspects of partnership agreements is knowing when a bid is forcing and when a bid is non-forcing. If we make what we think is a slam try with a forcing bid and partner passes, this will be a disaster. Agreeing on which bids are forcing and how forcing they are is important!

Modern Constructive Bidding

Invitational vs. Game Forcing Rebids by Responder

- Jump Rebids after Opener shows a Balanced Hand– Invitational
 - o Rebid a new suit below first bid suit usually natural and non-forcing
 - Use New Minor Forcing to force the auction with a good hand (Invitational+)
 - Responder's Reverse is forcing for 1-round (Invitational+)
 - o Jump Shift to a lower ranking suit is usually natural, non-forcing, and invitational
- Jump Rebids in Unbalanced Auctions Invitational
 - o Rebid a new suit below first bid suit, after 1-suited by Opener, non-forcing constructive
 - Use 4th Suit Game Forcing to force the auction with a good hand
 - Responder's Reverse is forcing for 1-round (Invitational+)
 - Jump Shift to a lower ranking suit is usually natural, non-forcing, and invitational

Competitive Bidding Auctions

First principle of competitive bidding is "Jumps in competitive bidding tend to be weak!"

Traditional Auctions

- Positive Free Bids New suits show values
 - New Suit Forcing
 - How Forcing depends upon the level of the freebid 1L, 2L, 3L
- Negative Doubles competitive values, but unlimited
 - o I have enough values to take some action, but no other bid looks attractive
 - Looking for a fit or a better fit
 - Usually two places to play

Non-Traditional Auctions

- Strength Showing Doubles (and Redoubles) "Good Hand"
 - Vs. Notrump Value-showing doubles, penalty oriented
 - X after 1NT Overcalls
 - X after 1NT Responses
 - X after 2NT Responses
 - X after 1NT Advances
 - O Vs. Double Value-showing redoubles, setting up penalty doubles
 - XX after Takeout Double by Interferer
 - XX after Negative Double by Responder
- "Negative Free Bids" New suits competitive, non-forcing
 - Responder's Negative Freebids
 - Advancer's Negative Freebids
 - Vs. Opponent's Takeout Doubles 2L not 1L

Other Forcing and Non-Forcing Concepts

- Fast Arrival Auctions
 - Q=LR+ Auctions 2L vs. 3L in competition, rebidding suit
 - o Jumps to Game in GF Auctions Jacoby 2NT or Splinters
- Bidding after 1NT Interference.
 - o 2-Level is Competitive
 - o 3-Level is Game Forcing
 - Simplesohl relay to compete Non-Forcing
 - Doubles "Card Showing" at 2L, Negative at 3L
- 2/1 in Competition "Partnership Style"
 - Does Responder promise a rebid?
 - O What bids by Opener are forcing?
 - What rebids by Responder are forcing?
- When are Responder's Second Bids Forcing?
 - o After a Support Double by Opener?
 - o After Opener passes competition around to Responder?
 - After Opener rebids 1NT, 2NT?
 - o After Opener rebids their suit?
 - o After Opener makes a jump rebid?
 - o After Opener bids a second suit, non-reverse?
 - After Opener's reverse?
